Driving South on I-77

Exit at #138 to Fairlawn. Turn right on Ghent Rd. Follow south for two miles. The Hilton is at the intersection of West Market Street (Rt. 18) and Ghent Road. Turn Right on West Market Street. Hotel is located on the left.
